This Cookies Policy is a part of our <u>Terms of Service</u> and <u>Privacy Policy</u>, together with your consent comprising our agreement with you.

## Chessreach does use cookies

Pursuant to Section 3 of our Privacy Policy, Chessreach ("us", "we", or "our") uses cookies and other technologies on the http://www.chessreach.com website and the Chessreach mobile application (the "**Services**"). By using the Services and clicking the respective buttons on our banners, you consent to the use of cookies for the purposes we describe in this policy.

# Cookies are...

Those small files comprising bits of text are installed on your computer or mobile device each time you open the respective Service. They enable our server to provide you with the information that is customized with your needs when you use some service the next time. Usually, your browser tells our systems if any cookies files were installed on your computer and as a result, we may analyze the information the cookies files give us.

## Kinds of cookies and purposes Chessreach uses them

Chessreach uses the cookies for the following purposes when entering the Service:

- to enhance your user experience: it enables Chessreach to keep you sign in if you wish, so there is no need for you to reenter the sign-in information each time you come to Chessreach Services; to enable us to see your actions and preferences on the Services, analyze this information and provide you with more relevant information on the Services you are currently using or may use;

- to enable the behavioral advertising: if you searched something or someone on our Services some time ago, the cookies remembered that and would remind you of your related needs later.

Categories of Use	Description
Authentication	If you're signed in to Chessreach, cookies help us to customize and enhance your experience with our Services.

Preferences, features, and services	Cookies can tell us which language you prefer and what your communications preferences are.
Performance, Analytics and Research	Cookies help us learn how well our site and plugins perform in different locations. We also use cookies to understand, improve, and research products, features, and services.
Advertising	Chessreach may use cookies in order to provide you with more relevant advertising when you use the Services. Cookies will enable us to know more about your prior visits on Chessreach and your activity within Chessreach, including the date and time of visits, time spent on the Website as well as the pages viewed, and websites previously visited. Chessreach may process such data through the external services, including but not limited to AdWords.

## Further opting-out from the use of cookies
